

Conference Terms and Conditions

The Accountants & Tax Agents Institute of New Zealand Inc (ATAINZ) Conference will take place as follows:

BOOKINGS

All applications to register for the Conference are subject to availability and Applicants making full payment. An Invoice/receipt confirming your registration will be sent to you within five (5) working days of receipt of your Conference payment.

CANCELLATION POLICY

If your circumstances change and you can no longer attend the ATAINZ Conference, you may cancel your registration booking by providing email notice to ATAINZ at admin@atainz.co.nz.

The ATAINZ Conference refund policy is as follows:

Cancellation before 1 month before Conference:
Cancellation between 30 & 14 days before Conference:
Cancellation less than 14 days before Conference:
no refunds

In the event that you cancel your Conference Registration ATAINZ shall refund to you the remaining fees, if any, within thirty (30) days of receipt of the cancellation notice.

Please note, that cancelling your registration does not automatically cancel your hotel and travel arrangements. Individuals are responsible for cancelling their own hotel and travel reservations.

CONFERENCE FEE

The Conference Fee is an "All Inclusive Fee" which includes such costs as venue hire, audio visuals, presenter fees, catering, entertainment, functions, transportation and administration. Other than as per the Cancellation Policy above no refund or discounts will be offered should you not attend any Conference Functions or any sessions of the Conference.

ATTENDEE SUBSTITUTION POLICY

Attendee substitutions, including those made on-site, are allowed with the written permission of the original registrant. Substitutions made less than one month before Conference will incur a \$50 processing fee.

PAYMENT

The fee for ATAINZ Conference must be paid in full at the time of Registration either by Credit Card or Bank Payment. Payment not made at time of booking may incur a 10% administration fee. If you arrive on-site at Conference with a balance due, you will be required to pay the full amount outstanding prior to attending Conference.

DIETARY REQUIREMENTS

ATAINZ will liaise with the Conference venues to advise of any dietary requirements. However, ATAINZ is unable to guarantee that all dietary requirements will be able to be catered for. It is recommended that if your dietary requirements are of a significant nature that you please contact ATAINZ so that arrangements may be made to meet your requirements.



CREDENTIALS

ATAINZ Conference issued credentials are the sole property of ATAINZ and must be surrendered upon demand to ATAINZ Conference Organiser representatives. ATAINZ Conference issued credentials must be worn while at the Conference or designated off-site activities. Failure to wear these credentials may result in refusal of admittance or removal from the Conference or off-site activity.
